Exhibitor Rules and Regulations

Location: De La Salle Chapel, 1940 Metro Road, Jackson's Point, Ontario LOE 1L0

Hours: 10 a.m. to 4 p.m. (set up starts at 8 a.m.) All vendors must be set up prior to 10 a.m. on Saturday, November 2nd, 2013. All vendors will be allowed to drive up to the building to unload. Vehicles must be removed immediately upon unloading. Take down from 4 p.m. to 6 p.m.

Health Certificate: It is the responsibility of any food vendor to provide a health certificate from the York Region Board of Health. York Region Board of Health vendor application attached. Please complete and email, fax or mail to the address on the form. The Health Department will do a full inspection before or during the festival.

- (1) **CONTRACT:** This application for space when accepted by Shoppe Locale, Canada (herein referred to as Management) shall constitute a contract between the Exhibitor and Management and in addition to its terms, shall include and incorporate the Exhibitor Rules and Regulations printed on this application, the tentative floor plan which the parties acknowledge may be amended and/or modified by the Management, and any additional rules and regulations which will be sent to the Exhibitor as part of the Exhibitors Kit prior to the show.
- (2) **QUALIFICATIONS TO EXHIBIT:** The Management reserves the right to remove, decline or prohibit any exhibit or part of an exhibit, or proposed exhibit, which in its opinion is not suitable to or in keeping with the character of the exhibition.
- (3) CANCELLATION: In the event an exhibitor whose application has been processed and accepted wishes to cancel prior to October 10th will receive a refund of monies paid less 50% upon receipt of written cancellation. NO REFUND OF EXHIBIT SPACE PAYMENTS WILL BE MADE AFTER OCTOBER 10TH, 2013.

- (4) **EXHIBIT:** The Exhibitor agrees to confine their presentation within the contracted space only and to maintain a staff in his/her booth space during the show hours while maintaining a code of behavior and dress appropriate for the Exhibition. Management reserves the right to relocate an exhibitor as it shall deem necessary to best display both the exhibitor and the show.
- (5) **EXHIBITOR INFORMATION:** Upon receipt of the completed application and exhibitor fee the exhibitor will receive via email an exhibitor information package.
- (6) **EXHIBIT SET-UP/TEAR DOWN:** The exhibitor agrees that no display will be dismantled or any goods removed during the show, but must remain intact until after the closing time of the Exhibition. The Exhibitor also agrees to have their exhibit set up and taken down by the final setup and take down time as set out above.
- (7) INSURANCE: The exhibitor is solely responsible for the placement and cost of comprehensive liability insurance on products/services with coverage of a minimum of \$2,000,000 limit of liability. The exhibitor also agrees to add The Town of Georgina as additional insured for the day of the show to its policy and to provide proof of insurance. Contact your insurance company or broker to provide proof of insurance for this event. The Town of Georgina provides \$2,000,000 liability insurance for the day of the show at a cost of \$15. If you require liability insurance from The Town of Georgina please add the cost of insurance provided for by The Town of Georgina to your vendor fee.
- (8) DAMAGES: The Management shall not be liable for damages, whether direct, indirect, general, special, consequential or otherwise to the exhibitor, its agents and employees or visitors to its exhibit whether occasioned by Management, its officers, agents or employees, or by another exhibitor.
- **(9) NON-DELIVERY OF THE BUILDING:** The Management will not be liable for failure to deliver the space in the event of the building becoming unavailable through fire, acts of nature, strikes, the authority of the law, or any other cause beyond its control.

The management has the right to make such changes, amendments, and additions to these Exhibitor's Rules and Regulations, as it shall deem necessary to the proper conduct of the Exhibition and thereupon the Exhibitor's Rules and Regulations shall rest with the Management and its decision shall be final. Management may require exhibitors to make suck alterations to their displays, as it deems necessary to the proper conduct of the exhibition and, on failure to comply, may order the immediate removal of the entire exhibit without compensation and at the exhibitor's expense.
